

Brown Marmorated Stink Bug (BMSB)

Dept of Agriculture measures for SEA FREIGHT shipped between: 1st September 2024 and 30th April 2025



#### Mandatory treatment overseas is required for:

- Break Bulk Cargo
- Open Top containers
- Flat Racks

or cargo may be re-exported or destroyed, as treatment in Australia is not permitted.



#### What's new?

- China and the Republic of Korea have been added for heightened vessel surveillance only.
- Emerging risk countries UK and China only.
- Introduction of AusTreat for offshore treatment providers.
- · Removal of the Vessel Seasonal **Pest Scheme**

## Importer Risks

#### **Delays / Additional Costs**

Where possible, we recommend all target high risk goods are treated overseas by an approved treatment provider if it has been manufactured in OR shipped from OR if it's transhipped through a target risk county (eg shipped from Finland but tranships via Germany).

NB: Treatment delays in Australia may result in additional costs for importers, as shipping line detention charges become applicable with the detention free time being eroded regardless of the reason for the delay. Additional transport, storage and depot costs will also be incurred as cargo is left waiting for treatment or inspection etc.

#### Cargo Packing

It is also very important that cargo is packed suitably for the BMSB treatment to be effective and compliant and please refer to following link for further details on this.

Suggest you also ensure your Contract of Sale / Orders / Incoterms, specifically include Treatment certificates from an "Approved Offshore BMSB Treatment Provider". A list of approved providers can be found on the following link:

#### **Treatment Options**



- heat treatment (containers need to be packed, so that heat treatment can be effective)
- sulfuryl fluoride fumigation.
- methyl bromide fumigation (not possible when temp is less than 10 degrees C. It's also banned in Europe)

### Expect treatment delays in Australia:

Biosecurity officer labour shortage / additional emerging risk countries (China & UK) adding to the expected high volume of BMSB affected cargo.

# Target high risk goods = mandatory treatment required

All tariffs under the following chapters are categorised as target high risk goods

United Kingdom and China, have been identified as emerging risk countries for BMSB and may be selected for a random onshore inspection.

**China** – random inspections apply to goods shipped between **1 September to 31 December (inclusive)** 

United Kingdom – random inspections apply to goods shipped between1 Dec to 30 April (inclusive)

In addition to the target high risk goods, chapters 39, 94 and 95 will be subject to random inspections for emerging risk countries.
